**Catechetical Leader
Religious Education Certification**
Beginning October 2021

All those working in catechetical leadership positions in religious education in parishes or elementary schools (i.e. DREs, CREs, directors of faith formation, etc.) must first meet the Catechist/Teacher Religious Education Certification requirements. Then, complete the following requirements for Catechetical Leader Religious Education Certification.

1. Complete the following online course requirements in **each competency area** listed below, from either the University of Dayton's VLCCFF online courses or the University of Notre Dame's STEP (total of 10 courses)*

*Catechetical Leaders may also submit any college credit courses in theology/religious studies (from a Catholic institution) to be reviewed for the competency areas by sending a transcript to the Director of Religious Education at samanthagrone@archstl.org.

OR

2. Have a BA or higher in Religious Education/Theology/a similar degree from a Catholic college or university. Please submit official transcripts to the Office of Catholic Education and Formation.

We will work with anyone who is currently in process toward a CRE/DRE certification to assist with alignment of your current status with the Catechetical Leader Religious Education Certification. Those who already have CRE/DRE status will maintain that status. (For more information about alignment, please go to the "If...Then..." section of the page.)

The Catechetical Leader Religious Education Certification does not have requirements for renewal, however, we encourage continued yearly professional development in religious leadership, administration, spirituality, and theology.

- **If I am currently working toward CRE Certification...**then, I should contact the Director of Religious Education to have an individual consultation to see where my courses align with the Catechetical Leader Religious Education Certification and which course(s) I will need to take to receive Catechetical Leader Religious Education Certification. (This will be considered on a case-by-case basis because of the variety of courses that may have been taken.)
- **If I already have CRE Certification (and I have NOT begun working toward DRE Certification)...**then, I maintain my CRE Certification.
- **If I already have CRE Certification, but am working toward DRE Certification...**then, I should contact the Director of Religious Education to have an individual consultation to see where my courses align with the Catechetical Leader Religious Education Certification and which course(s) I will need to take to receive Catechetical Leader Religious Education Certification. (This will be considered on a case-by-case basis because of the variety of courses that may have been taken.)
- **If I already have DRE Certification...**then, I maintain my DRE Certification.
